What is ArtJune? How many artists will participate?	ArtJune 2018 will be limited to about 50 artists representing a balanced variety of media.
When is ArtJune?	Saturday, June 16, 2018 (the day before Father's Day), 9 a.m. – 4 p.m.
Location	Court House Square, Downtown, Baraboo, Wisconsin
Who are the buyers?	Regional residents, tourists to Wisconsin Dells and Devils Lake State Park
Set up and hours of show	Set up after 4:30 p.m. Friday, June 15 (no overnight security) and/or Saturday, June 16 between 6 – 9 a.m. Event starts at 9 a.m.
Artist amenities	Unloading and loading assistance for artists. (Please, no driving on courthouse sidewalks.) Booth sitters available for breaks. PLEASE use off-site parking
Jury fee, Deadline and Notice of Acceptance	There is no jury fee; the booth cost is \$100. Applications are due by Friday, April 27. Accepted artists will be notified no later than May 11th. Applications will continue to be accepted for vacancies in some categories.
What is the booth cost?	The booth fee for accepted artists is \$100. Booth fee checks will be deposited June 1.
What is the booth size?	At least 12 ft x 12 ft
